

ACTIVITY RELEASE WITH LIABILITY WAIVER

I, the undersigned, do hereby wish to participate in the Sports League ("Activity") that is being coordinated by Belmar Sports and Belmar Baptist Church (individually and collectively herein "Belmar"). In consideration of Belmar coordinating such Activity, I acknowledge and agree, on behalf of myself, my spouse (if any), my children (if any), heirs, next of kin, assigns and anyone acting on my behalf to the following:

- I understand that my photograph, voice and/or likeness may be used in promotional or advertising materials of Belmar or by the organizers, promoters or sponsors of any related event. I consent to such uses and waive any rights of privacy or publicity I may have in connection with those uses.
- I realize that the Activity requires physical conditioning. I represent that I am in sound medical condition capable of participating in the Activity without risk to myself or others. I have no medical impediment that would endanger others or me. While participating in the Activity, I will follow all rules and procedures implemented or directed by Belmar, organizers, promoters or sponsors providing the Activity or related event.
- I realize that the Activity and its related events involve potentially hazardous or dangerous activities and conditions. I attend the Activity and all related events out of my own free will and choice. I will participate safely in the Activity within the limits of my own abilities and in a manner that does not endanger others or me. In choosing to attend the Activity and any related events, I fully accept and assume all risks, whether before, during or after the Activity and related events.
- I know and accept that accidents and injury may result from my participation in the Activity. These include, without limitation, physical injury, mental injury, emotional distress, trauma, sickness, illness, death, contact with other participants, equipment failure, the effects of weather, traffic, defects in facilities, exposed objects, walkways, stairs, unprotected holes, or vehicle or foot travel to and from an Activity. Belmar makes no representation or warranty that any rules, procedures or instructions in place have or will eliminate all risk and hazards or will protect me from injury or loss.
- I assume liability for and agree to pay my own medical and emergency expenses in the event of injury, illness, or other incapacity regardless of whether I authorized such expenses.
- I am participating in Activity at my own risk. I ASSUME, ON BEHALF OF MYSELF, MY SPOUSE (IF ANY), MY CHILDREN (IF ANY), HEIRS, NEXT OF KIN, ASSIGNS AND ANYONE ELSE ACTING ON MY BEHALF ALL RISKS OF DAMAGE, DESTRUCTION, THEFT, OR OTHER LOSS OF PERSONAL PROPERTY AND ALSO OF PERSONAL INJURY, INCLUDING DEATH, WHICH MAY OCCUR RELATED TO OR WHILE PARTICIPATING IN THE ACTIVITY, AND RELEASE, WAIVE AND DISCHARGE ALL RIGHTS TO SUE OR CLAIM AGAINST BELMAR, INDIVIDUALLY OR COLLECTIVELY, AND THEIR RESPECTIVE STAFF, SPONSORS, VOLUNTEERS, SCORE KEEPERS, REFEREES OR OTHER ACTIVITY PARTICIPANTS OR AGAINST SPONSORS AND ORGANIZERS OF ANY RELATED EVENT WITH RESPECT TO ANY LOSSES, INJURY OR DEATH.
